- Fraud
- Theft of University assets
- Misstated financial statements
- Misuse of University equipment and buildings

This form is designed to report alleged incident(s) related to non-academic violations that encompass behavior that is **not** related to an allegation of cheating or plagiarism nor sexual harassment/sexual misconduct, or discrimination. Examples include:

- Concern for a Student
 - *e.g. problematic behaviors including distressed, disruptive, and threatening*
- Concern for Faculty or Staff and/or Personnel Handbook Violations
 - *e.g. unethical behavior*
- Safety and/Security Concern
 - *e. g. theft, vandalism, etc.*
- Student Handbook Policy Violations
 - *e. g. alcohol, hazing, etc.*
- Not Sure/Other

This form is designed to report alleged incident(s) related to an allegation of sexual harassment/sexual misconduct, or discrimination. Examples include:

- Discrimination
 - *e.g. Disability, Race, National Origin, Pregnancy, Sex, National Origin, Age, Color, Religion, or Genetic Information*
- Harassment/Sexual Misconduct
- Dating Violence or Domestic Violence

- Bullying and/or Cyber-Bullying
- Stalking
- Retaliation
